

# International Students Tier 5 Government Authorised Exchange

For most international students who want to secure a graduate job in the UK, the Tier 2 (General) Visa is the main route. However, if you are unable to obtain a job offer under Tier 2 and are prepared to consider alternatives, or you just want to stay in the UK for a limited period to do an internship, then the Tier 5 visa is a route worth exploring further.

### Key features of Tier 5 Government Authorised Exchange (GAE)

- This programme is aimed at students/graduates who wish to do a period of work experience or training in the UK.
- The time duration is usually up to 12 months for work experience but can be up to 24 months for specific research or training. The length of time will depend on the scheme applied for.
- The visa is organised through a GAE sponsor on behalf of students (and employers).
- The GAE sponsor must issue a certificate of sponsorship before the individual can apply for the visa.
- There is a list of approved GAE sponsors on the government websitewww.gov.uk/government/publications/tier-5-government-authorised-exchange-schemes
- The post must be a skilled role, supernumerary (i.e. not a vacant job), temporary, and pay at or above the level of the national minimum wage.
- Students/graduates can apply from within the UK to switch from a Tier 4 student visa to a Tier 5 GAE visa if the job is **directly relevant to their degree.**
- Students/graduates can do a Tier 5 role not directly related to their degree but they must apply from their home country.
- Students/graduates have to pay a fee for the visa this is £230.
- Students/graduates must also have 'proof of support' funds of at least £945. These savings must have been in your bank account for at least 90 days before application.
- The individual must leave the UK on completion of the period of work experience and cannot switch to Tier 2 within the UK. However if a Company wants to offer the person full-time employment in the UK, they can apply for a Tier 2 visa for them once they have returned to their home country, but the more stringent version of the rules will apply (i.e. the 'Resident Labour Market Test' and the cap on numbers of visas).
- (This information is not relevant to students wishing to do a placement as part of their degree course. For this, check information on the Careers Service and Student Union Advice Centre websites regarding taking a placement whilst on the Tier 4 student visa.)

This information is summarised below for your use but these are only examples of schemes, please check the list for full details of all schemes.

## Introductory section - example below

# Section explaining about the Tier 5 visa - example below

The UK government has created a visa, the **Tier 5 Government Authorised Exchange (GAE)**, under which international students can work in UK companies for up to 12 months. The visa is administered by a Sponsoring Organisation (further details attached\*), which undertakes all the paper work re the visa. **The requirements of the visa are that the internship must be a skilled role, supernumerary (i.e. not a vacant job), temporary, and paid at or above the level of the national minimum wage.** 

## Section explaining about why you want to do an internship - example below

I would be very interested in undertaking such an internship with your company which is directly related to my Management degree. This could possibly be on a project that your company is interested in carrying out. I am keen to do an internship in order to gain practical managerial experience and to make a contribution to UK industry and commerce.

## Section explaining about what you have to offer - example below

#### Paragraph section explaining about the Tier 5 visa-example below
